- 2. **Fall Season Schedule Men's Open Division 1 and/or 2**: A motion was made and seconded that the six (6) teams in proposed Men's Open Division 1 and the seven (7) teams in proposed Men's Open Division 2 be combined into a single Men's Open Division 1. Upon a second motion made seconded and approved, the prior motion was to be determined by a majority vote of only those Team Reps for teams which would comprise these two (2) proposed Divisions present and voting. Upon vote by these Team Reps, the prior motion was adopted.
- 3. **Approval of Fall Season Schedule**: Jon presented the proposed Fall Season Schedules and requested comments and/or revisions.

Upon motion duly made and seconded, the proposed Fall Season Schedule was approved subject to further revisions by Jon and approval by the Executive Committee and with the proviso that the final Fall Season Schedules will be e-mailed, placed in packets and made available at the NEOASA website (www.neoasa.org).

RESOLVED:

(2) that any men's or women's team that finishes in first place in the highest men's or women's division in next Spring Season's competition will be entitled to enter the 2010 Soktoberfest Tournament without payment of the required team entry fee.
