Overview of Team Representative and Referee Responsibilities and Rules Overview

- There are No Pets allowed at Torchia-Oliver SoccerPlex. I understand that it is my responsibility to inform my team and anyone associated with my team of this rule, and if disobeyed I could be asked to leave the complex.
- There are No Glass Containers allowed at Torchia-Oliver SoccerPlex. I understand that it is my responsibility to inform my team and anyone associated with my team of this rule and if disobeyed I could be asked to leave the complex.
- Use of foul and abusive language will not be permitted. Referees are to enforce
 this ruling. I understand that if my team or anyone associated with my team uses
 foul and/or abusive language the referee can eject players, coaches, send off
 others associated with my team, and even terminate games. I understand that my
 team can also be fined if such infractions occur.
- When there is an instance of a player on my team serving a suspension, I will annotate on the game form and notify the referee of the player sitting out for said suspension. For example, "Serving game 1 of a 2 game suspension."
- I have/will/shall continue to read NEOASA's "Constitution, Bylaws, and Rules and Regulations". Being informed of how NEOASA is structured and how it operates. I understand that it is my responsibility to obtain a copy of said "Constitution, Bylaws, and Rules and Regulations".
- I will make sure my team and those associated with my team pick up after themselves. Leaving tape, refreshment bottles, beer cans, and trash on the fields is unacceptable. It costs NEOASA time and money to have the trash picked up off the fields. These costs are transferred to player registration costs.
- Torchia-Oliver SoccerPlex will be locked up no later than 30 minutes after the last game of the night. As team representative I will ensure to have my team out by that time to allow NEOASA to lock up the complex.
- As team representative, I understand that we must have a representative at ALL NEOASA meetings. This helps ensure all teams and players are well informed about upcoming events as well as changes in rules and regulations. Failure to send a representative to meeting will result in fines being levied against my team.
- As team representative, I understand it is my responsibility to make sure that I am playing legally registered players, and these said players are not in violation of the dual registration rule. Handwritten names on game forms are not permitted. Such players will not be allowed to play if they are not listed on the official game form. I understand that fines and forfeitures may occur if these rules are not obeyed.
- Make sure all players have unique numbers that stay affixed during the entire game; tape that falls off in 10 minutes of play is not acceptable.
- Driver's licenses may only be used to identify a player for the first game of the season only. Otherwise each player must have a NEOASA player pass with his/her picture on it to be a legally registered player.

- As team representative, I understand that I am responsible for turning in the game forms within the times stated in the Rules and Regulations. Failure to do so will result in not obtaining points in the standings which are used for state playoff eligibility. Currently, that time frame is 72 hours from time the game is finished.
- As team representative, I MUST provide one or more valid email addresses for contacts on my team to be assured that someone on every team receives ample notification of meetings and other important communications from NEOASA. If an email is not working or not longer used, notify the office as soon as possible to correct the problem.
- Reschedules need to be handled through email for confirmation purposes. The phone call can start the process, email or fax should be used between NEOASA and both teams to settle and confirm reschedule dates.
- Red card comments and referee complaints must be emailed/faxed/mailed to the office, then forwarded to the Discipline Committee.
- Inform all dual registered players that it is not possible to accommodate everyone during field scheduling. There will be times that the dual registered player might be late getting to their next game due to field scheduling.
- Torchia-Oliver SoccerPlex is for league play/tournament use only. NEOASA
 Teams or individuals engaging in unauthorized practices or scrimmages will be
 subject to a \$250 fine.
- If a team fails to show up, a team fields less than 7 players, the field is not ready, or other reasons that a forfeit is ruled by the referee, it is the referee's responsibility to turn in the game forms noting the infraction that caused the forfeit. Also, the referee must note on the game forms if the offending team paid referee fees and how much they paid. This way NEOASA can ensure which crew gets paid their full amount from the offending team.
